Statistical Reports

- [Annual Report of the Director: Judicial Business of the United States Courts](#) - The most comprehensive set of detailed statistical tables published on the work of the federal Judiciary, plus charts and text explaining why increases or decreases occurred in the courts' caseload. Provides data for the fiscal year ending September 30 for the U.S. courts of appeals, district courts and bankruptcy courts; the probation and pretrial services system; and other components of the federal Judiciary. Judicial Caseload Indicators table compares the Judiciary's current fiscal year caseload to its caseload 1, 5, and 10 years earlier. Publications dating back to 1997 available on line.
- [Bankruptcy Statistics](#) - Statistics on bankruptcy petition filings are available for 12-month and 3-month periods ending September 30 (the fiscal year), December 31 (the calendar year), March 31, and June 30. Tables dating back to 1990s—and sometimes earlier—available on line.
- [PACER Bankruptcy Statistics](#) - Report F-5A provides data on business and non-business bankruptcy petitions filed, by chapter of the bankruptcy code, for a 12-month period. It displays totals by county, as well as for each judicial circuit and district. County codes are determined by the county of residence of the first named debtor in each bankruptcy petition.
- [Federal Court Management Statistics](#) - Provides statistical profiles for each of the 12 U.S. courts of appeals and 94 U.S. district courts—plus national totals for the appellate and district courts—for the fiscal year ending September 30. Presents data based

on the number of authorized judgeships and provides rankings among the appellate courts and among the district courts. Compares current fiscal year data to data for previous five fiscal years. Publications dating back to 1997 available on line.

- [Federal Judicial Caseload Statistics](#) - Statistical tables on the caseload of the federal Judiciary for the 12-month period ending March 31 address the work of the U.S. courts of appeals, district courts and bankruptcy courts, as well as the federal probation and pretrial services system. Contains charts and summary text discussing reasons for increases and decreases in the courts' caseload. Judicial Caseload Indicators table compares the Judiciary's current fiscal year caseload to its caseload 1, 5, and 10 years earlier. Publications dating back to 2001 available on line.
- [Judicial Facts and Figures](#) - Provides current and historical caseload statistics for the U.S. courts of appeals, district courts, and bankruptcy courts for the fiscal year ending September 30. Table 1.1 is a good source for judgeship information, including the total numbers of active and senior Article III judges (who are appointed for life), magistrate judges, and bankruptcy judges.
- [Statistical Tables for the Federal Judiciary](#) - Prepared twice each year, with one volume reporting data for the 12-month period ending June 30, and the other volume reporting data for the calendar year ending December 31. Detailed statistical tables address the work of the U.S. courts of appeals, district courts and bankruptcy courts, as well as the federal probation and pretrial services system. Judicial Caseload Indicators table compares data for the current 12-month period to that for the same period 1, 5, and 10 years earlier. Publications dating back to 2001 available on line.
- [Wiretap Reports](#) - Uses tables, text, and charts to

report information provided by federal and state officials on orders authorizing or approving interceptions of wire, oral, or electronic communications for the calendar year ending December 31. Presents data on types of offenses under investigation, nature and locations of intercept devices, costs and durations of intercepts, and intercept extensions granted. Does not include names, addresses, or phone numbers of subjects under surveillance. Publications dating back to 1997 available on line.

The sources for the data were the *Annual Report of the Director*, the *Judicial Business of the United States Courts*, *Federal Court Management Statistics* and a few unpublished statistical tables. Specific data sources are noted on each table for easy reference. Except where specifically noted, data were compiled from the published report of the fiscal year noted (i.e., 1995 data are from the 1995 *Judicial Business of the U.S. Courts*). There have been minor revisions to some numbers in subsequent publications. For example, pending data are frequently revised in the subsequent year's publication. In addition, when the reporting period changed in 1992 from the twelve month period ending June 30 to September 30, a number of filing totals for fiscal year 1990 were revised in the *Judicial Business of the U.S. Courts*. Several tables in this report include data that reflect the revisions.

Judicial Facts and Figures does not offer an analysis of the federal caseload changes, although significant fluctuations in the data and corresponding explanations are noted on the tables. More detailed information can be found in the *Judicial Business of the U.S. Courts* in the year(s) where the fluctuation(s) occurred.

(1) Total appeals filed increased 41 percent between 1990 and 2002 and are up 19 percent over the past four years, driven mostly by the increase in immigration-related administrative agency appeals and criminal appeals. The increase in filings of administrative agency appeals began in February 2002, after the Attorney General ordered the Board of Immigration Appeals to clear its backlog of cases, stating that this action was required to help prevent terrorist attacks and enforce the nation's immigration laws.

(2) In 2001, rumors of a one-year deadline for filing petitions pursuant to *Apprendi v. New Jersey*, 530 U.S. 466 (no such deadline actually existed) resulted in a large jump in motions to seek such petitions in the U.S. Courts of Appeals.

The proportion of pro se appeals filed has decreased 4.7 percent since 2001, reflecting the 4.9 percent decline in prisoner petitions filed between 2001 and 2005.

FOOTNOTES

(1) Filings for recovery of defaulted student loans decreased from 1990 to 1995 due to a change in Department of Education (DOE) policy on collection of delinquent loans. Renewed growth peaked in 2000 as a result of streamlining of the loan processing system. In 2001, DOE implemented new administrative measures that caused fewer student loan cases to be filed in federal courts, as reflected in the 88% drop in these cases.

(2) Filings for recovery of overpayments of veterans benefits have decreased significantly as the Department of Veterans Affairs has used administrative actions and the Internal Revenue Service to recover overpayments rather than filing suit in district court. (4) Civil rights filings increased significantly after 1990 largely because of the Civil Rights Act of 1991 and the Americans with Disabilities Act of 1990. Filings in all categories of civil rights were down in 2005, resulting in a 10 percent decline from 2004.

(1) Filings for recovery of defaulted student loans decreased from 1990 to 1995 due to a change in Department of Education (DOE) policy on collection of delinquent loans. Renewed growth peaked in 2000 as a result of streamlining of the loan processing system. In 2001, DOE implemented new administrative measures that caused fewer student loan cases to be filed in federal courts, as reflected in the 88% drop in these cases.
